

Justice for Jeremiah.



Outline of the Case of the Suspicious Death of Jeremiah Duggan:

On 27 March 2003 the body of a British student Jeremiah Duggan was found at the side of a dual carriageway, five and a half kilometres outside the town of Wiesbaden in Germany. At 5.45 am that morning, Jeremiah had made several telephone calls to his family and girlfriend, telling them that he was in big trouble and that he believed his life was in danger. Then at 6.10 am it was alleged that Jeremiah was hit and run over by two cars and killed. The German police decided immediately that this was suicide, closing the case without further investigation. The police took no formal witness statements, failed to investigate the full circumstances, failed to release to the family the clothes Jeremiah was wearing, failed to carry out a post mortem, failed to carry out a medical examination of injuries or to take notice of the parents' requests for a full investigation. There was no forensic examination of the cars nor was the alleged traffic death investigated as a crime scene.

Jeremiah was studying at the British Institute in Paris when he was recruited from the streets of Paris to attend what he thought was an anti-war conference in Germany. The conference was organized by the Schiller Institute in Wiesbaden, Germany.

The Schiller Institute is a front group for the movement headed by Lyndon LaRouche, which operates a youth cadre on an international scale. Lyndon **LaRouche is a convicted criminal, who served five years of a fifteen-year prison sentence in the US.** The LaRouche organization is documented as a political cult with a history of terror tactics, fraud, and intimidation.

Jeremiah had made a **public statement during the conference saying he was a Jew.** This was done in response to the way that the Jews were being blamed for the Iraq war and all the world's evils. For the last thirty years Lyndon LaRouche, a notorious conspiracy theorist, has published misinformation worldwide inciting hatred against the British and the Jews, with such misinformation frequently being picked up by the Middle East press. On initial view, this misinformation may seem so outrageous that it has often been dismissed as a joke, but underneath the codes, hate figures and falsifications, the incitement to hatred continues. One of the conspiracy myths is that the British Tavistock clinic is a part of the British Intelligence and that it programmes dangerous assassins who are sent worldwide to attack the enemy (including the LaRouche organization) so as to help the British to spread their power throughout the world. The LaRouche organization spreads these anti-Semitic and anti-British conspiracy theories amongst unsuspecting people, and employs a smokescreen of high culture with homage to poetry, music, art and mathematics.

The title of "Schiller Institute" is given to a "cultural institute" headed by Lyndon LaRouche's wife Helga Zepp LaRouche. On the morning of Jeremiah's death, Helga Zepp LaRouche described him, at a meeting in their offices, as a British Jew and a representative of the enemy sent over from Britain by the Tavistock clinic to harm the LaRouche organization. Jeremiah's body was found five minutes from the Executive Intelligence Review (the LaRouche Organization's press agency), but according to the German authorities' documents, he was alleged to have run five and a half kilometres in a short time from a flat in Wiesbaden where he was alleged to have been staying to the place where he was allegedly hit and run over by the two cars.

Wiesbaden is the European headquarters of the LaRouche organization.

Recently LaRouche has concentrated his plans to expand his youth movement in Europe. This means canvassing outside colleges in France and Germany to recruit young people to abandon their studies and become full-time members of the LaRouche organization.

New Evidence; Failure to Investigate.

A forensic pathologist of international repute studied the British post mortem report and the 75 photographs of the scene his findings were that it was not possible that Jeremiah could have been hit or run over by any cars, as there were no signs on his body or the clothes of being run over, and no traces on the vehicles of human hair or tissue or clothing, and also quoting other forensic details.

Other contradictions include: damage to the cars cannot be reconciled with the kind of damage likely to have been caused by collision with and running over of a human body. Also the tracks on the road do not match the cars nor match the braking systems of those cars nor is it clear how the body could be found on that position on the road according to the descriptions given. Paul Canning, expert UK forensic photographer, found no evidence on the cars to show there was contact with a body, and this is backed up by the German traffic accident reconstruction expert who stated that there were no deposits on the cars of blood, or cloth. Also, it is confirmed by German authorities that there was no forensic examination of the cars to establish how the damage to the cars occurred. Jeremiah's passport, which was not with his body, but in the hands of the LaRouche organization, was handed over to the German police. Recent tests showed it was splattered with Jeremiah's blood.

This compelling new evidence raise profound reservations about Jeremiah's death being caused by a traffic accident, as was first assumed at the time of the death. The British pathologist Dr Shove met with Erica Duggan and read the post mortem report he had done and told her that Jeremiah had been severely beaten around the head and that he noted no sign on the body of having been run over by a car. This raises the question "Did Jeremiah die from head injuries inflicted by severe beating or kicks to the head, or was he hit or run over?"

In October 2008 German Politicians Professor Weisskirchen, Hans Christian Stroebele, British Politician and Liberal Party President Simon Hughes, Hamburg State Sect Advisor Ursula Caberta, Senior History Lecturer Dr Matthew Feldman and USA Political analyst Chip Berlet

together with families from the USA, France, Germany and UK agreed at a public Forum held in Berlin that the LaRouche/Bueso group is a totalitarian group disseminating anti-semitic conspiracy theories and poses a danger to society and a threat to the individual.

For the last seven years the Duggan family took legal action in Germany, showing how there has been a violation of Articles 2, 3 and 13 of the European Convention on Human Rights, but the case has been refused by the Constitutional Court in 2010. We have further information about Jeremiah being attacked prior to his death so whether he suffered from a mental or/and physical attack the case remains unexplained. The family continue to pursue Justice in Britain through the Inquest system and in Germany by submitting new evidence to the authorities as it is reported to them. Lawyers are preparing the case now for the Court of Human Rights as there has not been a proper investigation of a very violent suspicious death.

Any organization that poses a threat to youth, causes suffering either by physical or mental harm or is responsible for spreading anti-Semitic propaganda and the incitement to hatred deserves serious investigation by German, British and French authorities.
