Dear Sir or Madam,

I am writing to request assistance in the investigation of the unexplained death of Jeremiah DUGGAN who was killed in Wiesbaden, Germany on Thursday 27th March 2003.

Jeremiah DUGGAN was a student aged 22 years who was studying for two degrees at a College in Paris. He was Jewish and had a good relationship with his parents who were divorced. He had regular contact with both his mother and father. He had a French girlfriend who was also a student living in Paris. Jeremiah was extremely popular with a great sense of humour and a love of life. He was idealistic and was very concerned about the war with Iraq. His ultimate aim is to become a writer.

He became involved with a male named Benoit Chalifoux (editor of newspaper 'Nouvelle Solidarité') and was subsequently invited to a number of political meetings. Jeremiah was eager to protest against the Iraq war and Benoit promises him he could write for his newspaper.

On Friday 21st March he obtains a lift from Chalifoux and others to attend a conference at the Schiller Institute in Wiesbaden where Lyndon LaRouche is speaking. Later that day he telephones his girlfriend and informs her that the lectures are interesting.

On Monday 24th March he again contacts his girlfriend telling her he would be returning to Paris the following day and that he had attended a lecture on 'Chanting'.

Tuesday 25th March Jeremiah contacts his girlfriend and states that he would be getting a lift back to Paris the following Sunday. He is upset. He rings again an hour later and is troubled and mysterious.

Wednesday 26th March Jeremiah attends a Rembrandt exhibition in Frankfurt and stays overnight at a flat belonging to Rainer Apel (Wife of the Intelligence Director of the Schiller Institute) sharing a room with another male called Sebastian.

On Thursday 27th March (0320 GMT) Jeremiah contacts his girlfriend in Paris and tells her in a faint voice that he is under too much pressure and that he can't talk over the phone. He informs her that he has very serious things to tell her and would be returning to Paris the next morning.

At 0424 GMT Jeremiah contacts his mother on the phone and tells her that he is in serious trouble. He is extremely frightened and asks her to come to Wiesbaden NOW to rescue him.

Jeremiah's mother is obviously distressed at this phone call and fearing for her son's safety contacts Colindale Police Station and then Special Branch,

Forty five minutes after the phone call to his mother Jeremiah is killed 5 kilometres outside Wiesbaden when running across an autobahn

The following day Erica and Hugo Duggan travel to Wiesbaden to establish what had happened.

The police at Wiesbaden inform the parents that it was a clear case of self destruction and that there was no need for an investigation. Allegedly there were no witnesses to the death apart from the drivers of the vehicles. They told the parents that Jeremiah was suffering from psychological problems.

Jeremiah DUGGAN was returned to England and the Coroner opened and adjourned an inquest. Jeremiah died from massive head injuries. He had an Inordinate amount of urine in his body and toxicology confirmed that he had not taken any drugs.

After reviewing a substantial amount of documentation from the parents I feel the investigation thus far into the death of their son has been totally inadequate and request the following questions be answered by the German authorities:-

In General Terms

1. What is their procedure for the investigation of unexplained deaths?
2. How many self destruction (suicides) have they experienced over the past 5 years on a year by year basis.
3. How many of these self destructions have been students aged between 18 — 25,
4. What research has been carried out in relation to the Schiller Institute and the LaRouche Youth Movement?

In Relation to Sebastian Drochon

1. Where is the Police Report? His parents or the Coroner has received no report.
2. What corroborating statements were taken?
3. What investigation was undertaken?
4. Was any Closed Circuit Television footage seized? If not why not?
5. Where is Jeremiah's Clothing?
6. If Jeremiah was going to kill himself why run 5 kilometres out of town to do so with an extremely full bladder?
7. Where *is* the evidence to substantiate the claim that he had psychological problems?

These are just a few basic questions that need to be answered. As far as I can ascertain there is no evidence of a premeditated suicide. There is definitely no history of psychological problems and to the contrary a frightened distressed call to his mother would surely heighten one's suspicions.

I have researched through the Internet the Schiller Institute and La Rouche Youth Movement, it appears to be a political cult with sinister and dangerous connections- It also blames the Jewish people for the Iraq war and ail the other problems in the world. Jeremiahs lecture notes and bulletins showed the anti semetic nature of ideology. Their recruitment tactics have been highlighted in research documentation throughout the United States of America. They prey on students aged between 18-24 and use physical and mental manipulation. Students then abandon their studies and concentrate on

promoting Lyndon LaRoche to become the next president!


Has Jeremiah been subject to some kind of mental manipulation by the LaRoche Movement?
